ORDER:

The Chief Electoral Officer, AP in the Memo 1st read above has stated that the Election Commission of India has communicated the certain guidelines towards transfer / posting of Officers who are directly connected with conduct of election going State / UT as part of their consistent policy view of upcoming General Election to the House of People (Lok Sabha) and State Legislative Assemblies of AP., Arunachal Pradesh, Odisha and Sikkim and decided, among others, that;

No officer connected directly with elections shall be allowed to continue in the present District (Revenue District) of posting:

(i) if she/he is posted in her/his home District.

(ii) if she/he has completed three years in that District during last four (4) years or would be completing 3 years on or before 30th June, 2024,
While calculating the period of three years, promotion to a post within the district is to be counted.

2. The CEO, AP has therefore requested to process the proposals and issue posting orders in the matter in consultation with them immediately. Accordingly, the Govt., has requested the C&DMA, AP vide Memo.2nd read above to furnish the necessary proposals duly following the guidelines. The C&DMA, AP has furnished the transfer and posting proposals to the Government vide letters 4th and 5th read above in the category of Municipal Commissioners working in the State.

3.
